Summer is a time to spend time with family and friends to relax and reconnect, however families are not always easy to navigate, so I just wanted to take this opportunity to raise awareness of children and young people who are "Privately Fostered", a group of children who often go unnoticed, but it is important that everyone working with children and young people is able to recognise a private fostering arrangement so that we can keep those children safe.

In 2003, Lord Laming completed a report following the death of seven year old Victoria Climbie who had been sent to Britain by her parents to stay with her Great Aunt and Partner, this was an example of private fostering. Tragically Victoria died with 128 injuries to her body at the hands of her carers. Victoria's death led to changes in legislation and imposed a duty on all of us to identify private fostering arrangements so that appropriate safeguards can be put in place.

A child is privately fostered if they are under the age of 16 (18 years if the young person has a disability) and move to live with a person who is not a close relative, and that arrangement lasts for over 28 days. We have developed a quick and easy to watch guide here to provide more detailed information, It was developed locally in Stoke on Trent and will only take a couple of minutes to watch.

## **Multi-Agency Audits**

Following on from our last newsletter where we told you about Joint Targeted Area Inspections (JTAI), we wanted to share some updates...

In preparation for a JTAI, we have started to undertake Multi-Agency Auditing across the partnership. This will allow us to self-evaluate how well local agencies work together to protect children.

The audit looks at the Child's voice and lived experience, partnership with parents, assessment, planning and intervention across agencies, and over all the collaborative practice to achieve better outcomes for children and young people in Stoke-On-Trent.



The aim of these audits is to assure ourselves that families are receiving the right help at the right time, Children and their families benefit from evidence-based approaches that reduce risks and meet their needs as well as the quality and timeliness of help and support prevent children's needs and risks from escalating.

The first set of Audits have recently been completed and the learning from these will be shared via the Quality Assurance Group to inform areas of practice improvement required and how we can collectively achieve this.



#### Staffordshire Police Public Protection Unit

Staffordshire Police are investing resources into the new Public Protection Unit. This includes an investment of 90 additional staff into the Public Protection Unit and a North and South Child Exploitation team. This will be led by Chief Superintendent who will be the Public protection

#### Lead.

Staffordshire Police are also moving towards building a Stoke Multi-Disciplinary Team that is co-located to help safeguard children that are at risk of exploitation and bring to justice those that are exploiting them.

- The Child safeguarding lead will be Supt. Nicky Furlong.
- The Adult safeguarding lead will be Supt. Victoria Lee.
- The Stoke-on-Trent Child Protection and Safeguarding Lead will be DCI Rob Taylor
