## Stoke-on-Trent City Council News

### Director of Children's Social Care, Safeguarding and Early Help

Following the planned recruitment for the permanent Director of Children's Social Care, Safeguarding and Early Help, **Florah Shiringo** will be continuing in this role until January 2027.

This will provide continuity of management for this service and will allow us to implement the Family First Partnership Programme without the disruption of a change of Director, who has been leading on this key transformation project.

## Changes to the Integrated Front Door

Dear Colleagues

### Notification of changes to the Integrated front door Children's services Stoke-on-Trent

As you are aware, Stoke-on-Trent Integrated front door introduced a Portal system in May 2025 as the main referral route for our partners referring into the local authority. This also led to our local authority exiting the information sharing log (ISL) and introducing a MASH Delegation Portal for information sharing purposes.

We have listened to your views and feedback, and we understand and appreciate that there are several challenges to both portal systems and as a partnership concerns, potential risks and vulnerabilities have been raised and these are acknowledged.

To mitigate against these risks, we have reviewed our current system and would like to take this opportunity to seek your agreement to make some changes. We propose to suspend the use of the MASH Delegation Portal for information sharing purposes and to consider reverting to use of the information sharing log (ISL) as an interim position. We consider this to have the least impact upon our partners and internal staff whilst mitigating against risk in the most speedy and efficient way possible.

We would also like to take this opportunity to obtain your views on the current referral portal system and our proposal to progress to a hybrid model which allows us to have a conversation-based approach for referrals for most of our partners while maintaining the referral portal for some of the referrals and requests. We have taken into consideration the views of partners and internal colleagues and we appreciate the benefit of the portal system for some colleagues such as the Probation Service, 111 services, Ambulance Service and court requests.

The Integrated Front Door will remain the principle point of contact for children's social care and early help services. It is a well embedded service, and we value the benefits of having conversations with our partners and recognise the effectiveness of joint decision making, this is in keeping with our relational practice approach.

We appreciate that changes have been made in the past with limited communication about the proposed changes. We recognise that your engagement in this process has been limited, leading to some of the challenges we see today.

We would therefore seek all partners views on the above proposals in order that we make these changes as soon as possible. Please confirm in writing your views to [SoTSCP.Information@stoke.gov.uk](mailto:SoTSCP.Information@stoke.gov.uk) by **Wednesday 29 October 2025**.

Thank you in advance for your understanding and collaboration in what we foresee will be a shared journey of change with an agreed partnership arrangement to ultimately meet the needs of children and families.

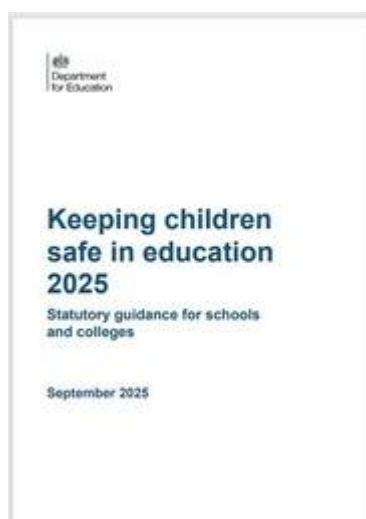

## Keeping Children Safe in Education (KCSiE) 2025

The updated [Keeping Children Safe in Education](#) guidance was published on 1 September 2025.

When the Department for Education ran its Safeguarding Children in Schools and Colleges: A Call for Evidence (March–June 2024), the intention was to use that evidence to shape future, more substantive iterations of KCSiE. At the time, the consultation page noted that only technical changes would be made in 2024, with a wider update expected for 2025. However, the 2025 version has once again been limited to technical changes, and does not contain the broader revisions that had been anticipated.



# Early Years Foundation Stage (EYFS) Statutory Framework

There are two statutory EYFS frameworks:

- EYFS statutory framework for childminders
- EYFS statutory framework for group and school-based providers

The EYFS framework:


- sets the standards that all early years providers must meet to ensure children learn and develop well
- ensures children are kept health and safe
- ensures children have the knowledge and skills they need to start school



The frameworks that came into force in September 2025, include new requirements on references.

## Centre of expertise on child sexual abuse


The CSA Centre has launched an eLearning course, identifying and responding to **intra-familial child sexual abuse**. The course takes just 90 minutes to complete, is entirely free and consists of three engaging modules, with interactive tasks, video explainers and a final assessment.

## Understanding and Responding to AI Generated Child Sexual Abuse Material

The Internet Watch Foundation has developed a guide for professionals in response to the increasing amount of AI generated content being produced (up 400% in 2025). The concern is that it may be inevitable that full length AI generated child sexual abuse films will be produced – and these synthetic videos will become indistinguishable from real footage. Due to the ever-increasing challenges with tackling CSA, it is hoped that this guidance will be of benefit.

# Domestic Abuse Awareness Month October 2025



Every October, communities around the world unite to shine a light on the devastating impact of domestic abuse, to support survivors and to call for collective action to end abuse.

Domestic abuse is not only widespread but deeply damaging to individuals, families, and communities. According to the Office of National Statistics:

- In the year ending March 2024, **4.8% of adults aged 16+ (around 2.3 million people)** reported experiencing domestic abuse in England and Wales.
- Police in England and Wales recorded **1.35 million domestic abuse-related incidents and crimes**, with 851,062 flagged as domestic abuse crimes, representing **15.8% of all recorded crime**.
- Around **72.5% of recorded victims are women**, though men are also significantly affected.

Over a lifetime, an estimated **9.9 million adults (20.5%)** in England and Wales have experienced domestic abuse.

## New Era

The New Era Domestic Abuse service provides free, confidential support for all those affected by domestic abuse including adults, children and families.

### New Era's Victim Service

Free confidential support is available for victims of domestic abuse, 24 hours a day, 7 days a week by phone or live webchat. The service also has dedicated specialist advisors working with LGBTQ+; Black, Asian, Minority Ethnic and Refugee (BAMER) communities; male victims and older victims, as well as those with a disability. Specialist support is available for both adults and children.

### New Era Behaviour Change Service

New Era's Behaviour Change service provides help to anyone who is displaying unhealthy or abusive behaviour within their relationship and wants to change this. Specialist support is available for both adults and children.





### Helplines Insight Briefing: young people's experiences of suicidal thoughts and feelings

NSPCC Learning has published a Helplines Insight Briefing using insights from **18,981** Childline counselling sessions in 2024/25 on young people's experiences of suicidal thoughts and feelings. In **80%** of these, young people were seeking support outside a crisis. Themes include when thoughts/feelings occur, attempts at help-seeking, unhelpful responses, and different coping mechanisms. Professionals can use these insights to reflect on how they respond and support young people who talk about thoughts and feelings like this.

Magnets and Button Battery Awareness 2025

Be aware!

Magnets and Button Batteries

Magnets and button batteries are in everyday objects like car key fobs, remotes and children's toys. But did you know that if they are swallowed they can badly injure, or even kill a child?

Batteries react with saliva and if a child swallows a button battery it can burn holes and cause internal bleeding, or even death.

Magnets can rip through a child's gut if they swallow them, causing life-threatening injuries, or even death.

**Tragically, two young children in Staffordshire have died from ingesting a button battery, and a magnet.**

- Symptoms may not be obvious.
- Your child might be coughing, gagging or drooling, or pointing to their throat or tummy.
- Unclear or fluctuating symptoms mean it is important to be vigilant.
- Trust your instincts and act fast even if there are no symptoms.

They can be fatal if swallowed.

If you think your child has swallowed a battery or a magnet, take them straight to the nearest A&E department or call 999 for an ambulance
